

Auto Auctions Form National Unit Here, Elect C. B. Drake

A National Auto Auction Protective association organized here Saturday night aimed Sunday at protecting auction owners and customers from "undesirable" dealers and sellers.

Auction owners from six Mid-western states threshed out their problems in the Orlando hotel, coming up with a set of officers, a board of directors, and locating of a clearing house at Kansas City.

C. B. DRAKE, owner of the Drake Auto auction in Decatur, was named president of the association. The owners had assembled here at Mr. Drake's invitation.

Other officers:

Ken Schaefer, owner of the Ken Schaefer Auto Auction in Indianapolis, vice president.

David C. Watson, secretary, and Mrs. Lillian Hamilton, treasurer. They own the Public Auto auction in Kansas City as a partnership.

The clearing house, to which association members will report irregularities and which will pass on reports to the rest of the membership, will operate from the Public Auto Auction offices in Kansas City.

Association officials, who met until 3 a.m. yesterday and finished their organization efforts later in the morning, said they hope eventually to enlist most of the nation's estimated 500 auction owners.

THE ONLY membership restriction will require that applicants be automobile auction owners.

Mr. Schaefer said a need exists for a protective organization, similar to credit bureaus, which can help break up car theft rings, passing of fraudulent checks, and "any irregularities of buying or selling cars at auction."

He explained that the association will be self-supporting and self-informing, with information contributed by one member passed on by telegraph to the rest of the membership. Members may query the clearing house when they are uncertain of any phase of a transaction.

"Most auctions have some trouble with undesirable dealers and it's increasing," Mr. Schaefer declared. "This is a comparatively new business, and we're looking to the future. We're finding different ways of meeting our problems."

OFFICIALS of the new association agreed that in most auctions a quarter of a million dollars will change hands during the selling of from 150 to 200 automobiles in four to five hours.

Using \$50,000 as a conservative average for each auction in the country, they declared the total weekly turnover would be at least two and one-half million dollars.

CAR AUCTION GROUP FORMED.

Two Kansas Citizens Are Officers of Protective Association.

DECATUR, ILL., Aug. 29. (AP)—Twenty-five owners of motor car auction places in six Mid-West states formed the National Auto Auction Protective association today.

Its purpose, they said, is to protect auction owners and customers from "undesirable dealers and sellers" and to combat the selling of stolen cars, passing of fraudulent checks at auction sales, and other irregularities.

The group plans to set up a clearing house in Kansas City which will receive reports of irregularities and telegraph them to members. The organization said it hoped to include all the estimated 500 car auction owners in the country.

Michigan also was represented in the organization.

David C. Watson, 1700 New Jersey avenue, Kansas City, Kansas, and Mrs. Lillian Hamilton, 3519 Bales avenue, are partners in the Public Auto Sales company, 4503 East Twenty-seventh street. Mrs. Hamilton was a partner in a public motor car auction which formerly operated at the old Riverside race track in Platte County. Both were in Decatur last night.

Auction Operators Form Protective Association

DECATUR, ILL.—Formation of a National Auto Auction Protective Assn. was announced here last week with the election of C. B. Drake, Drake Auto Auction, Decatur, as president of the association.

The association is designed to protect auction owners and customers against "undesirable" dealers and sellers, to afford a central clearing house for information relative to the buying and selling of used cars on the wholesale markets and as a checkup system on stolen cars and bad check artists, it was declared.

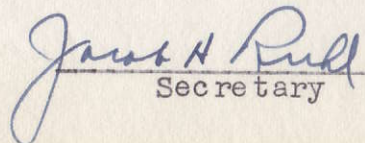

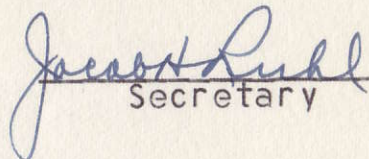

September 28, 1957

The Board of Directors held a special called meeting by the President at the Hotel Sherman on the above date with the following directors and officers present. on the topic "What's Wrong With People". Mr. Geo. Leiste, Vice-President of Seven Provinces Insurance Company also gave a short talk during the luncheon period.

At 2:00 P.M. the President, Mr. Anspach again called the Meeting to order.

The Secretary read the minutes of the Miami Convention and they were approved as read.

Copies of the Treasurer's report were given to each member and it was accepted.

Mr. R. A. Waldrep expressed his grievance with regards to the article which appeared in the Automotive Market Report naming the Seven Provinces Insurance Company as the official Insurance Company of the Association. A motion was made by Mr. Tom Beasley that the President be allowed a modest expense account to attend the various zone meetings. The motion was seconded and passed.

After considerable discussion a plan was made that each Auction pay into the Association the sum of \$1.00 per car sold of which \$.75 per car will be the premium for insurance and \$.25 per car remain in the treasurer of the Association.

The purpose of the \$.25 per car into the Association was to be used in some method of cooperative advertising and promotion of Auto Auctions and that an executive vice-president be hired to represent the Association at the Automobile Factories through the factory Used Car Manager.

The members had luncheon in the Presidential Suite of the hotel and representatives of three automobile publications were present: Automotive Market Report, Butler, Pa.; The Carcaster, Lansing, Mich.; and Auto Dealer's Report, Hartford, Conn.

The meeting was called to order by Mr. N. C. Maney, first vice-pres., due to the absence of our president, Denzil Webster.

Mr. Maney welcomed the old members together with the three new members present. The new members are: Mr. Bill Cunchula of Emlenton Auto Auction, Emlenton, Pa.; Mr. C. W. Shaw and Mr. L. G. Tribble of Southern Auto Auction, East Windsor, Conn.; and Mr. Jos. E. Johnson of Horseheads Auto Auction, Horseheads, N. Y.

Several communications were read by Mr. Maney. A telegram was received from King Kar Sutton saying he was ill and unable to attend; a card was received from Quincy Auto Auction stating that they were unable to attend.

Ohio Auction Law Upheld; Greiner Faces Writ Plea

TOLEDO.—The constitutionality of Ohio's 107-year-old law governing auctioneers was upheld here last week by Common Pleas Judge John Q. Carey, but the judge refused to order any action to enforce the statute in the case of Earl (Doc) Greiner, operator of a Toledo used-car auction on Madison Ave.

Ruling on an amended suit brought by Greiner in March after Common Pleas Judge Harvey Straub rejected Greiner's previous attack on the constitutionality of the law, Judge Carey observed that addition of the names of the county treasurer, auditor and sheriff to Greiner's suit made no difference in the issue.

Judge Carey also turned down the plea of Joel S. Rhinefort, county prosecutor, for an injunction restraining Greiner from operating his Toledo auction, ruling that this matter could not be considered with Greiner's present suit.

Rhinefort then informed the court that he would file another suit in a day or so seeking temporary and permanent injunctions against Greiner, which would also call for an accounting of all proceeds from his auctions and payment of taxes and penalties due. The auction law requires tax payment of 2 percent of every \$100 of sales.

Morton Neipp, attorney for Greiner, said that Judge Carey's decision would be taken to the court of appeals.
